## **Diploma Supplement**

The University ensures the recognition of the diplomas in local labor markets. The diploma supplement embraces detailed information on the degree obtained, completed academic programme, specialization and final state attestation marks.

Diploma supplement imparts the mode of study, the language of instruction, the name of the university, the address and the contact details of the university, a diploma supplement number, a registration number, the date of the conferral when the diploma supplement is issued in accordance with the decision of the State Attestation Commission, the official stamp or seal of the university, the name and signature of the official certifying the diploma supplement.

Additionally, diploma supplement embraces the information on the qualification, specialization and field of study, admission requirements, curriculum description, program details and grades obtained, grading system of HEI, rights and privileges provided by the degree (access to further study and professional status). Diploma supplement provides detailed information about the content and objective of specific courses within the study program.

These descriptions help to ensure transparency and facilitate the recognition of qualifications across different institutions and countries.

In addition to marks indicated in the diploma supplement, grades (A/B/C/D) have to be outlined, which could enhance transparency and mobility.

The diploma supplement manifests in the "Curriculum description" section what a graduate is able to do after completing his/her studies and receiving the qualification. The document indicates that upon earning the degree the holder of the qualification becomes entitled to carry out professional activity (employment) in accordance with the level of education and qualification by this specialty. To be more specific, having earned the bachelor's degree a graduate will be able to handle a big diversity of topics and work in the sectors such as secondary schools, academic lyceums and professional colleges, public administration bodies and the mass media.

The diploma supplement clearly lists the number and the names of the courses (modules) that have to be completed in order to obtain the qualification. The total hours as well as the hours allocated to each course (module) are outlined. The diploma supplement indicates credits attached to every course. The diploma supplement outlines the grades obtained for each subject.

The diploma supplement encompasses supplementary achievements such as a qualification practice, final state attestation marks as well as the names and grades of course works.

The diploma supplementary manifests information on the national higher education system.

The higher education system in Uzbekistan includes universities, institutes, academies, providing a comprehensive range of programs from undergraduate to doctoral levels. Access to higher education requires the completion of secondary education and passing national entrance exams. The qualifications structure consists of Bachelor's (typically 4 years), Master's (2 years), and Doctoral degrees (3-4 years for a PhD). The system is aligned with international standards to ensure the recognition and comparability of Uzbek qualifications globally.

The National Qualifications Framework of the Republic of Uzbekistan provides qualification frameworks for industries, professional and educational standards, as well as unified mechanisms for recognizing qualifications at national and international levels for all levels of qualifications. The National Qualifications Framework includes eight qualification levels in accordance with the European Qualifications Framework and the Law of the Republic of Uzbekistan "On Education," as well as the main ways of achieving corresponding qualification levels according to the appendix. The eight levels incorporate practical experience, practical general secondary education, primary professional education, secondary general education, secondary professional education, undergraduate education, postgraduate education and further education. The National Qualifications Framework is a tabular structure that includes knowledge, skills, and abilities, personal and professional competencies required to perform professional activities at each qualification level, as well as the path to obtaining the corresponding qualification level.

The diploma supplement in the university context meets quality requirements when it extensively outlines the completed academic programme with precise course details, grading systems, learning outcomes, and national education system context. It should provide comprehensive and transparent information, aiding international recognition and facilitating seamless understanding and comparability of the graduate's qualifications. The diploma supplement meets the quality requirements since it encompasses the information on program details, grading system of HEI and learning outcomes.

The diploma supplement provides precise course details in "Program details and grades obtained" section. In accordance with the decree of the Cabinet of Ministers of the Republic of Uzbekistan No. 607 dated July 19, 2019 "On Approval of State Samples of Bachelor's and Master's Diplomas on Higher Education

Information", the diploma supplement clearly lists the number and the names of the courses (modules) that have to be completed in order to get the qualification. The total hours as well as the hours allocated to every course (module) are displayed.
